City Water Leak Adjustment Policy: <u>Leak Adjustments</u> – The City will provide a credit to a user's water bill once every two years in the event of excessive water use caused by a plumbing leak. In order to receive a bill adjustment, the user must provide to the City documented proof that the leak has been repaired, *e.g.*, a service invoice or receipt for materials. Afterward, the City will provide an adjustment to the water bill by recalculating charges associated with the volume rates for up to six months. The City will apply the prevailing volume rates to the user's average monthly water consumption prior to the leak. In the event that history is not available for the user, volume rates will be applied to an assumed monthly consumption of 7,500 gallons, in order to calculate an adjusted bill. The leak adjustment will not apply to a user's fixed charges, which will be billed as normal.

The application fees shall be charged as an initial deposit for processing the application, and payment shall be required as part of a complete application. In any event, all applicants shall be liable for, and required to pay, the City's actual or average cost of having outside professionals (e.g., City Planner, City Attorney, City Engineer, etc) perform reviews of the applicant's materials. In cases where the City uses such professionals to perform reviews of application materials, work and interact with the applicants, and make recommendations on the applications, the City will also charge (and the applicant will also be responsible for) the hourly rates of these professionals.

Payment is due and applicants must be current on all outstanding expenses prior to hearing and again prior to further action finalizing or supporting a land use decision.
