Motion to Approve City Council Minutes: Feb 16th, 2022:

David Skakel:

Hazardous Waste Steering Committee (formed in early 2000's): Many people know what the program does, many still do not. Primarily we set policy and do outreach for best practice, garbage, and recycling. We would love to have Mosier as a voting representative on our steering committee, we have been absent a Mosier rep for more than a year. (Formerly Councilor Valitchka filled this seat). We are treading thin on representation.

City submits in writing who they would like to appoint- Jayme is interested. Anyone else? Sam MSM can help fill the void if for some reason Jayme cannot.

Appoint Jayme Bennett for the representative of City of Mosier for the Hazardous Waste.

Action item: Jayme email David Skakel the letter from the city appointing her as rep. (Appoint Jayme Bennett as the steering committee rep for the program for the tri-county area, which has the authority to pass an annual budget and pass grants). Really glad to have Jayme representing and half of our agencies have a staff member fill the position, rather than a council seat.

If Jayme needs to resign, MSM can post the request or help with outreach.

Business Item I: Jacob's Skate Park Presentation/Proposal:

Brief introduction on the volunteer group that has been busy touring skateparks, meeting with designers and builders of parks and doing community outreach.

A couple questions - if you know from other places- liability concerns with hosting events?

Action: Jayme follows up with CIS on risk assessment. (Recreational immunity applies).

Stormwater and concrete question on environmental impact -
Smaller committee look at all 3 potential locations and find one that would work.

The city can help with this process with public engagement, and we have full support from the mayor.



Mayor B got a call from head of Portland timbers has a program to build soccer fields, does Mosier want a soccer field? Possibly contact school or MSM to pursue.

A skate park would be a better fit for our current needs.

But to Andrea, her children, and our community this is a sweet idea that we can also make sure we have something to keep him in our minds, hearts and otherwise going forward to.

One of Arlene's (Mayor Burns) female friends was inducted into the hall of the fame in California, and she knows Tony hawk as well, and Arlene would be happy to assist in any outreach here as appropriate.

Stormwater runoff won't be a problem, the soil is permeable.

Swale and offsetting the impact will be incorporated, as well as research into any sustainable method, approach, and tree preservation.

Business Item III: John Grim: Transportation Funding Update

Action plan for all grants for 2022-2023

Focus efforts on grants we will get - avoid low scoring criteria

FLAP - we are making changes to the grant we have opened already - it is a solid application, very well done - one issue - small mistake - the cost was off by an order of a typo.

Designing the remainder of HWY 30 is one use of this funding proposed.

Safe Routes to School (SRTS)- Score criteria do not fit well.

Max is 2m - cash match is 20% (400k) - and it would be a difficult match for us at this time.

Though, we can use funded projects as match - such as the improvements on the corner of 3rd and center.

Part one is due this Friday, our score is low because of the criteria about the school itself.

Low attendance or high minority is a preference.

Recommendation is to stop moving forward on this effort and redirect to other sources.

Congressionally directed spending - transportation, rural broadband and Oregon getting 50m Water projects too.



This could be perfect for infrastructure money. It's a little different than the congressionally spending to community directed projects - different pot of money.

Closes April 1 - internet application - very brief/informal application process.

Office Hours: Jayme to propose a static schedule to be available to public 20 hours a week with incremental increases allowing for adjustments and consistency.

Additionally, continue considering and pursuing hybrid options for public meetings as we are also sensitive to our Most vulnerable population (the Senior Center).
