1. Business from the Audience: Short Term Rental Ordinance

Jim F: Regarding the Short Term Rentals) STR's regulations and approvals, here to listen.

Laura reviews the commercial CAP in zone associated with STR's -

Every current residential use in Mosier is an existing non-conforming use. All uses are non-conforming, and with non-conforming uses, so do they lose the residential use all together with a full shift or not?

You lose the residential non-conforming use status if you apply for an STR and are in commercial zone.
