A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MOSIER AGREEING TO SUBMIT A LETTER OF INTEREST TO THE STATE OF OREGON'S TRANSPORTATION AND GROWTH ASSISTANCE PROGRAM, PARKING REFORM AND MANAGEMENT DIVISION, TO CONDUCT A PARKING STUDY IN THE CITY OF MOSIER.

WHEREAS, the City of Mosier recognizes the importance of effective transportation and parking management in fostering a vibrant and sustainable community; and

WHEREAS, the City Council of the City of Mosier acknowledges the increasing need to address parking challenges and enhance mobility for residents, businesses, and visitors; and

WHEREAS, the State of Oregon's Transportation and Growth Management (TGM) program offers support and resources for local governments to plan and implement transportation and land use improvements that promote livable communities; and

WHEREAS, a comprehensive parking study is essential to understanding current and future parking needs, identifying strategies to optimize parking resources, and supporting the City's overall transportation and growth management goals; and

WHEREAS, exploring the TGM program aligns with the City's commitment to sustainable development, economic vitality, and improved quality of life for all residents;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mosier, as follows:

1. The City Council agrees to engage the State of Oregon's Transportation and Growth Management (TGM) program for the purpose of conducting a parking study in the City of Mosier.
2. The City Council directs city staff to draft a letter of interest to submit to TGM program staff, and gather letters of support from local stakeholders.
3. The City Council encourages community involvement and input throughout the exploration process to ensure that the parking study reflects the needs and priorities of Mosier's residents, businesses, and visitors.
4. The City Council will consider the findings and recommendations of the parking study and take appropriate actions deemed beneficial by City Council and Administration.
5. This resolution shall be in full force and effect immediately upon its adoption by the City Council.
